SPECIAL EVENTS AND TOURNAMENTS WILL REQUIRE ADDITIONAL FEES FOR ROOM MODIFICATIONS.

Please note these important changes & notices:

- Tables & Chairs are included in the above rental fees based on availability.
- The Floor Plan is required at the time the contract is prepared.
- Rentals may require a Parsippany Troy Hills Township Fire Permit charge per day.
- There will be no kitchen access allowed.
- All contracts require a 50% deposit, and all balances must be paid 30 days prior to the event. Please refer to the contract for payment details.
- The PAL rents Gym(s) only for sports and athletic activities.
- An insurance certificate is required to be presented to the PAL upon request.
- Organizations address residency will be based on certificate of liability insured or other required documents.
- At the discretion of the PAL, approved security and/or extra staff is required whenever there are PAL activities/children present in the building. The contract holder will be billed at a rate to be determined.
- There is to be no vendor activity in the hallways or parking lots unless previously approved by the Executive Director prior to the event and specifically listed in the rental contract. Failure to follow this policy will result in additional charges being assessed and the potential forfeiture of future rental opportunities.
- **Cancellation Policy GYM:** If notified and confirmed by Main Office, at least **72 Hours PRIOR** to event, you will receive a full refund. If notified and confirmed by Main Office, **WITHIN 72 Hours** prior to event, you will receive a 50% refund. Any cancellations day of event will receive no refunds. Inclement weather cancellations will be handled case by case.
- **Cancellation Policy APR:** If notified and confirmed by Main Office, at least **45 DAYS PRIOR** to event, you will receive a full refund minus a \$75 cancellation fee. If notified and confirmed by Main Office, **44-30 DAYS PRIOR**, you will receive a 50% refund. Any cancellations **LESS THAN 30 DAYS** of event will receive no refunds. Inclement weather cancellations will be handled case by case.
